As the PARENT(S), I (we) agree to the following:

- 1.) I understand that I am fully responsible for my child's education and that Achieve! Christian Academy will assist and encourage my student in their educational journey throughout the academic school year.
- 2.) I understand that the registration fee of \$125 per student per year and the supply fee of \$100 per student per year is due in full to register and reserve a seat for my student. Class size is limited and seats are reserved on a first-come, first paid basis. Director reserves the right to decline enrollment of any student for any reason. Registration fees and supply fees are non-refundable and non-transferable, unless the director declines enrollment of the student prior to class starting.
- 3.) I understand first semester tuition is due in full by Friday, September 3rd, unless payment arrangements have been made prior to this date. Second semester tuition is due in full by January 4th, 2022, unless payment arrangements have been made. Payment is due in full whether our child finishes the year or not. The Director may refund a portion of your pre-paid tuition or waive tuition payments IF a new student is able to take your place AND if the student leaves in good standing. Students asked to leave due to conduct issues or other problematic issues as determined at the Director's discretion will NOT be refunded.
- 4.) I understand that I must purchase the required textbooks and supplies needed for my student and that the student should bring all books and supplies to class as needed and instructed.
- 5.) I understand that the curriculum guide is proprietary and may not be shared with other families not enrolled in Achieve! Christian Academy.
- 6.) I understand I am the primary teacher of my child and will ensure that my child will complete all work given to the best of their ability.
- 7.) I understand that if there is a conflict, I agree to a conflict resolution plan whenever possible. Major conflicts could result in immediate dismissal if the Director determines the conflict to be serious in nature and a positive resolution would not be possible.
- 8.) I understand that classes are held in the private home of the Director and her family. The student and parents, siblings, etc. picking the child up are to respect the privacy and home of the Director and family. The student (and all visitors) are to remain in the classroom at all times, unless directed otherwise. Use of the bathroom(s) are permitted, but the student / visitor must respect privacy and not open any cabinet doors or drawers unless directed by the Director to do so. Students / visitors are permitted to "hang out" in the kitchen / dining room before and after classes and during lunch. Students are permitted to use the microwave in the kitchen for reheating their lunch.
